# Why Activism Is So Important

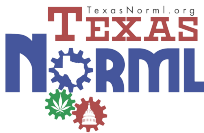


- No Ballot Initiative Option

- Reliant on elected Texas State Senators and Representatives

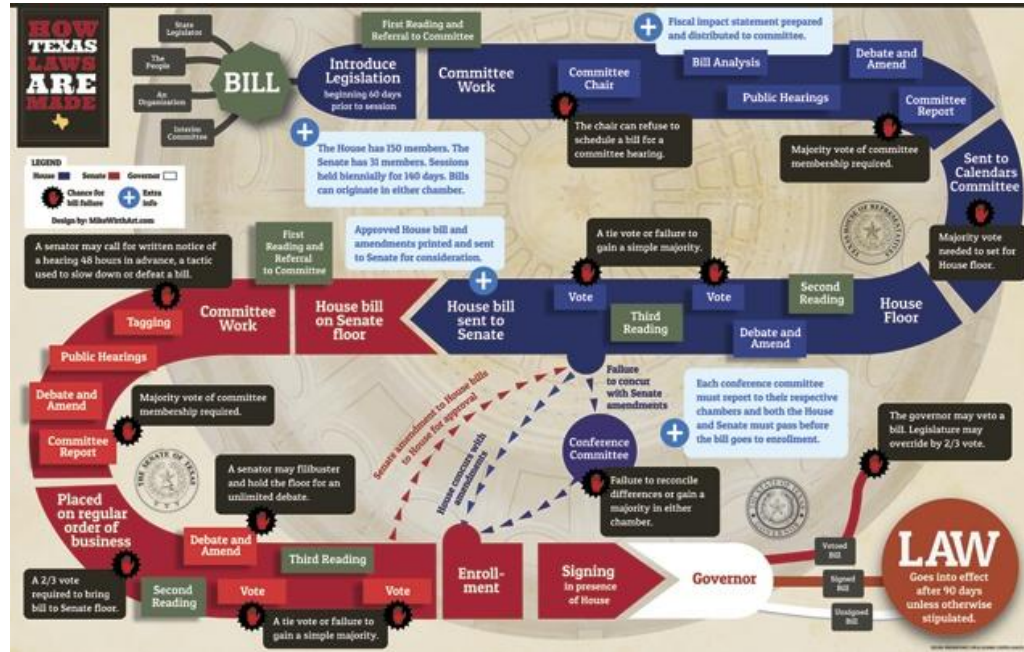
# Political Cycle

- Primary Runoff Election
  - Early Voting: starts **July 6, 2020** | Election Day: **July 14, 2020**
- During the summer, political parties hold state conventions to update their platforms. These are very important because it give guidance to elected officials and helps the Party craft their messaging.
- Voters must register by October 5th, 2020 to participate in General Elections
- General Election
  - Early Voting: **October 19-23rd, 2020** | Election Day: **November 3rd, 2020**
- Legislators start to prefile bill on **November 9th , 2018**

# Helpful Tips for Crafting Testimony

- Keep your personal testimony to one page. (*During a hearing, you will have a max of three minutes to tell your story.*)
- Start off with your name and your support for medical cannabis. (*Please note we will not include bill numbers at this time, keep generic for use.*)
- A moving story has these elements: a protagonist (you, a family member), an antagonist (law enforcement, unjust laws, injury, disease), a plot (the chain of events), the climax (the most important event) and a theme (the lesson we want legislators to learn from the story).
- Select your top 3 talking points and focus on them. (*Research on your elected officials will help you customize.*)
- If you have to use medical terms or a specific name for an illness, do briefly describe what it means so that those seeing your testimony can understand your story better. (*Use reliable sources when referencing your medical condition.*)

# Helpful Tips for Crafting Testimony

(continued)

- Stay away from making claims about anything or anyone but yourself, but if you must, then do **cite your sources**.
- Read over your testimony a few times to make sure you are clear in what you want to say and to ensure that there are no errors. *(Keep in mind that once your testimony is submitted, it could be further edited for length, clarity, grammar, layout, adding of bill numbers and punctuation.)*
- Stay on subject. The subject is marijuana, unjust laws, the victims of unjust laws, and how marijuana heals us.
- Sign off with your name, city and any contact information that you would like to include. Pictures are a great way to personalize your testimony.
- Do not include any profanity, obscenity, slurs or threats in your testimony. Those will not be included.
- Save any criticisms and accusations for another time. **This is the time to focus on your story.**



Dear Texas Legislators,

My name is Major David Bass. I served twenty-five years in the U.S. Army. I am a veteran of Desert Storm and Operation Iraqi Freedom. I use cannabis as medicine. I am sixty percent disabled for chronic pain from injuries I received in the Army and for Post-Traumatic Stress Disorder (PTSD) related to my service in Iraq. I use cannabis because it is safer and more effective than opioid pain medications and psychotropic drugs. The opioid medications are addictive and I would have to take them the rest of my life. The psychotropic drugs have terrible side effects. Cannabis allows me to function normally without the pain and without the symptoms of PTSD.

The problem is that in Texas, I am a criminal for using cannabis. I purchase my cannabis illegally and I use it illegally. But I do not live my life like a criminal. I have been married for thirty-eight years, I own my home, I pay my taxes, I vote—I am a productive, honest citizen in my community. What I need is to be able to talk to my primary care physician about cannabis. I need to be able to purchase cannabis that has been grown in a state-regulated grow facility and sold in a state licensed dispensary. I am a retired Army officer and a proud veteran of two wars. I do not want to be labeled a criminal in my state. But if I have to choose between addictive pain medications and psychotropic drugs that make me nonfunctional, or cannabis, then I choose cannabis. My health is primarily my responsibility. I have to make a logical choice. And my experience the past seven years using cannabis as medicine proves that it is an effective medication for chronic pain and PTSD.

I hope that you will listen to Texas veterans and allow us legal access to this plant that heals us and allows us to lead productive lives as proud citizens of Texas.
