| HB 1535 (Rep. Klick) | Would add Cancer, Chronic Pain, and PTSD for Veterans while allowing the Department of State Health Services to add new qualifying conditions through their administrative rule-making process. HB 1535 would also raise the THC cap to 5% and create "Institutional Review Boards" which will facilitate research and track the impact of medical cannabis on patients participating in the program. | Passed the House (Vote: 134 to 12) |
| HB 567 (Rep. Frank) | Would protect parents whose children are enrolled in TCUP from CPS. | Passed House & Senate (Votes: House - 143 to 5 Senate - Unanimous) |
| HB 4307 (Rep. Lucio) | HB 4307 would create insurance coverage for low-THC cannabis under certain group benefit plans for governmental employees. | Sent to House Local and Consent Calendar |
